



*Should one borrow money at a higher rate than the property can earn, a scenario arises in which the use of the borrowed money has a negative benefit, leading to earning less as a percentage return than an "All Cash" purchase. Likewise, should one borrow at a lower rate, positive leverage is created, and one would earn a higher return than an "All Cash" purchase.*
